It was in 1776 that Saint-Just's parents bought this house, built a decade earlier. Saint-Just lived there until September 1792, when he took his seat in the National Convention.

Louis Antoine de Saint-Just (1767-1794) is one of the most important figures of the French Revolution. The house where he lived from 1776 to 1792 can be visited in Blérancourt

The Association pour la sauvegarde de la Maison de Saint-Just (Association for the preservation of Saint-Just's House) was founded in 1985 on historian Bernard Vinot's initiative, in the aim of saving Saint-Just's house, of restoring it and of giving it a cultural destination.

The Association facilitated the acquisition of the house by the town of Blérancourt in 1989. Then it contributed 163,000 F to the restoration works that allowed for the rehabilitation of the House and its restoration to its former appearance.

Saint-Just's house was opened to the public in 1996 and since 2010 it has housed a bilingual interactive exhibit devoted to Saint-Just and the French Revolution. Once again, the Association contributed not only financially (30,000 €), but also scientifically (drafting texts, choosing images). It intends to continue to enrich the permanent exhibit and to regularly organize temporary exhibits.

At the same time, the Association maintains a policy of purchasing manuscripts in Saint-Just's hand, including several new discoveries published in the *Annales historiques de la Révolution française*.



It organized the colloquium *Grandes figures* de la Révolution française en Picardie ("Great Figures of the French Revolution in Picardy)" at the time of the Bicentennial and, in 2017, the *Colloque Saint-Just du 250*^e anniversaire ("Colloquium on Saint-Just for his 250th Birthday").

In 2017, the Association organized, in the Aisne but also in Decize, Saint-Just's birthplace, and in Paris, an ensemble of events for Saint-Just's 250th birthday. Among these was the inauguration, in the House, of the exhibit *Saint-Just vu par les artistes*, 250 ans d'images et de légendes ("Saint-Just as seen by artists, 250 years of images and legends").

In June 2012, a fire seriously damaged Saint-Just's house. Following this fire, the Association pour la sauvegarde de la Maison de Saint-Just launched a subscription campaign destined to make up for the destruction caused by the accident with additional restorations. We invite you to support this campaign.
